- 7. Revise and edit.
- 8. Type a final draft. Revise and edit again if necessary.
- 9. Turn in your completed, typed essay.

Persuasive Writing Prompt

Situation

You are living with your family in ancient Greece in the city-state of either Athens or Sparta. (You choose). You have a relative who lives in another city-state and is thinking of relocating to either Athens or Sparta. This relative has written a letter to you asking your opinion on which city-state (Athens or Sparta) would be the best place to relocate and why.

Question

Which city state in ancient Greece is the superior place for your relative to live:

Athens or Sparta? Consider the type of person your relative is. Is your relative old or young? Male or female? An artist or a warrior? The city-state you recommend should suit his or her needs.

Prompt

<u>Write</u> a five-paragraph persuasive essay in the form of a letter <u>explaining</u> why Athens or Sparta is the most superior city-state in which your relative should live. <u>Give</u> examples that <u>support</u> your argument in the form of **facts** from your research. <u>Discuss</u> issues such as **government**, **treatment of non-citizens**, **quality of life**, **culture**, **education**, **farming**, **military**, the roles of **males and females**, etc.

STEP 4: OUTLINE

INTRODUCTION

Salutation & Intro: How will you greet your relative?
Background: Begin your letter with personal questions regarding your relative and comments about your daily life in Ancient Greece.
Thesis: What is your essay about? State your opinion regarding which city-state to move to.

CONCLUSION: You've done all your research, what have you learned? "So What!?!?" Restate Thesis: In new words **Summarize Main Points:** Remind your relative about the most important reasons to move to Athens or Sparta. **Homerun Sentence:** End your letter with a provocative question or statement. Closing: FIRST BODY PARAGRAPH **Topic Sentence:** The first sentence of your first paragraph should be your counter argument. Although some Greeks may think that ______ is a better place to live, clearly it is not! **Details**: For example. . . **Support:** This shows that. . .

STEP 5: WRITING EXPECTATIONS

Formatting Guidelines:

- Your essay must be typed, and no less than one-and-a-half pages, and no more than three pages in length.
- Use only 12-point Times New-Roman font
- Include a salutation, not a title or a heading.
- Include a closing with your actual name in real life.
- Double-space and use only black ink.
- Indent paragraphs and do not put extra lines between them.

Other Writing Tips:

- Avoid sentences which start with: and, so, because, also, then.
- Use a thesaurus to replace boring or over used words with more descriptive, precise words.
- Be as specific as possible and do not use slang (thing, cool, gunna, guy, etc.)
- Use the pronouns you and I sparingly. Be more objective and less personal.


